## Lee Neighbourhood Plan Examination

Combined Borough response to the Independent Examiner's procedural letter and Questions.

## 1. Introduction

- 1.1. On the 31<sup>st</sup> September 2023 the London Borough of Lewisham (LBL) and the Royal Borough of Greenwich (RBG) submitted the Lee Neighbourhood Plan to the independent examiner Derek Stebbing BA (Hons) DipEP MRTPI.
- 1.2. As such the independent examiner has requested a response from the Councils to the following two questions:
  - a. Can the **Councils** please confirm that the status and designation of the Green Spaces for their respective Boroughs, as listed in the 4<sup>th</sup> column of this table, is correct
  - b. Can the **Councils** also please advise me whether the proposed additional designations of various sites within each Borough, as listed in the 5<sup>th</sup> column of this table, would be supported in relation to the relevant Local Plan open space policies and typologies
- 1.3. Both LBL and RBG have agreed to submit a combined response to the examiner's questions. Table 1.1. provides the combined response to the examiner's questions (A and B) found in paragraph 1.2 of this introduction.
